- A percentage of all fees paid are deducted from the value if you choose to purchase the instrument.
- Mountford Music will maintain the instrument for normal wear and tear, but responsibility for loss or damage must be borne by you.
- You must inform us immediately if the instrument is lost or stolen.
- The instrument must not be hired or loaned to another person.
- You are to notify us immediately if the instrument is no longer kept at the address listed on the agreement.
- Please insure this instrument with your company or with Marsh on 1300 760 171.
- Three months hire is due before instrument is delivered, you then agree to pay the hire fee every 3 months by the allotted due date.
- You will be invoiced every 3 months at the beginning of the month that your payment is due.
- If your account is not paid by within 15 day's you will receive a reminder email. You will then have 7 days to complete the payment. If after the allocated 7 days payment has not been completed, you will be charged \$5 for every subsequent week payment is late.
